ORDER


Subject : Appointment of Nodal officers of Ministry of Textiles to regulate the production, quality, distribution for supply of masks, melt Blown fabrics and other textiles supplies including all types of medical protective textiles to the Central Government to combat COVID-19.

In partial modification of this Ministry's Orders of even number dated 24.3.2020, 1.4.2020 & 8.4.2020 and in terms of the power conferred under Section 3(1) of the Essential Commodities Act, 1955 and further in terms of the notification no. S.O.1197 (E) dated 13.03.2020 of the Ministry of Consumer Affairs, Food and Public Distribution (Department of Consumer Affairs), following officers of Ministry of Textiles will act as Nodal Officers under the Act to regulate the production and distribution for supply of masks, meltblown fabrics and other textiles supplies related to COVID-19 for supply of all types of medical protective textiles to the Central Government required to combat COVID-19.


2. This order shall come in force with immediate effect and will remain in force for a period upto 30th June 2020 or till further orders.
