Textiles Committee, Government of India, Ministry of Textiles invites quotation for installation of overhead water storage tanks in its Guest House at Prabhadevi. The specifications of the water storage tank to be installed are as follows:

The terms & conditions are as under.

- a. The quotation (bid) shall be on the letter-head of the agency and submitted in a sealed cover superscribing **“Quotation for supply, installation, commissioning of Overhead Water Storage Tank on or before due date (06.11.2015) at 3.00 pm.**
- b. EMD of Rs.5000/- has to be submitted by way of demand draft drawn in favour of Textiles Committee payable at Mumbai
- c. The party shall have the competence in supply, installation of the water storage tank & plumbing works, party shall also submit the documents in terms of work order as proof of same.
- d. The design of proposed work is enclosed for reference.
- e. The party can visit Textiles Committee for inspection at site after taking prior appointment of the undersigned before due date.
- f. Successful party (bidder) shall have to deposit the interest free performance security @5% of total contract value.
- g. Textiles Committee shall not be responsible for any delay in receipt of quotation or non-receipt of quotation sent by post. The parties shall submit the quotation in the Admn-HK cell of Textiles Committee, Mumbai on or before the due date.
- h. Textiles Committee has the right to accept or reject all or particular quotation at any time without assigning any reasons thereof.
- i. The payment will be made on satisfactory delivery, completion and commissioning of the work as per the specifications contained in the work order and within the time as stipulated in work order.
- j. No damage shall be caused to the property of Textiles Committee while carrying out the assigned work. Any damage to property of Textiles Committee shall be recovered from the selected party in terms of money or replacement of said property
- k. The delivery, installation and commissioning of the water storage tank shall have to be made within 15 days at the said site of Textiles Committee, at Prabhadevi, Mumbai at the supplier's cost after receipt of work order.
- l. Any other conditions stipulated at the time of placing the Work Order shall have to be complied with.
